EXAM SCHEDULE

If a student has two exams scheduled for one calendar day or four exams scheduled in four calendar days or fewer, he or she may request to take an exam at an alternate time. For the purposes of this rule, take-home exams longer than eight hours are considered to be two different exams over two days, whereas take-home exams that are less than eight hours are considered to be one exam on one day. **EXAM ACCOMMODATION REQUESTS SHOULD BE MADE TO ALEXIS LANHAM.**

Times: Morning exams 3 hours and 15 minutes or longer will start at 8:00am; morning exams less than 3 hours and 15 minutes will start at 9:00am; all afternoon exams will start at 1:00pm; all evening exams will start at 6:00pm. **LAPTOP USERS MUST BEGIN SETTING UP 30 MINUTES PRIOR TO THE SCHEDULED START OF THE EXAM**, whereas **BLUEBOOK USERS MUST BEGIN SETTING UP 15 MINUTES PRIOR TO THE SCHEDULED START OF THE EXAM.** Bluebook rooms are listed below in (parenthesis).
