UPDATE July 29, 2025: Additional instructions for identifying books on the bookstore website and new ISBN for Mattioli's Contracts: Cases and Doctrine textbook.

Use this guide for precise textbook information and make sure you read the notes below carefully before ordering your textbooks. With the exception of Professor Lubin's book for Torts, everything listed here should be available from the IU Bookstore, though you can shop elsewhere. Please note that the Jerome Hall law Library provides free access to several of the recommended items.

4. Typically, professors want you to buy the print, especially in your 1L year, but you will notice that the bookstore website lists both print and ebook options. It can be hard to tell the difference sometimes because of the way publishers list the book, e.g., "Contracts: Cases and Doctrine w/connected ebook with study center" is a print book that also includes access to the ebook and other add-ons while "Contracts: Cases and Doctrine, Eighth Edition" is just the ebook. To ensure you are getting the right type, make sure the ISBN of what you're ordering matches the ISBN on this list.
