# **Application Instructions**



Please read the following instructions carefully. **The application must be completed in its entirety and submitted to the Office of Admissions, along with the completed Direct Admit Program Agreement.** Please keep a copy of your application for your records. Applications of non-matriculating students are retained for three years from the date of intended enrollment. Before we can review your Direct Admit application, we must receive the following:

## ACT or SAT Test Score Report

You must submit a score report with your application materials by the stated application deadline.

### Undergraduate Transcript(s)

We must receive an official transcript *directly* from each college where you received college credit that counts toward your undergraduate degree. Transcripts must be emailed to <u>lawadmis@indiana.edu</u> or mailed to the address below *directly* from the college or university.

### Letters of Recommendation

Please submit 2 letters of recommendation that attest to your potential success as a law student and as a member of the legal profession. Recommendations should be emailed *directly* from your recommenders to lawadmis@indiana.edu or mailed to the address below.

### Resume

Please submit a current resume which outlines your professional and volunteer experience, academic accomplishments, and other pertinent aspects of your background you wish to share with the admissions committee.

### **Personal Statement**

Please submit a 2-3 page personal statement that provides insight about you, describes your motivation to attend law school, and/or highlights your interest in Indiana University Maurer School of Law. A compelling statement will be clearly written, well-organized, and highlights the special strengths and experiences that you would bring to our law school and the legal profession. These may include, but are not limited to, demonstrated evidence of leadership, creativity, commitment to justice, service to others, cross-cultural competency, and significant work or volunteer experience. *This statement should include reason(s) why you are interested in continuing your education at Indiana University-Bloomington.* The personal statement must be a maximum of three pages, double-spaced, using 12-point font with one-inch margins. Please submit the personal statement with the application.

### **Adversity Statement (Optional)**

IU Maurer recognizes that some applicants have faced and overcome significant adversity in life. In this optional essay, you may share any information about adversity or challenges that you would like us to consider about your life which may have limited your educational opportunities or negatively impacted your academic performance. This may include social, economic, or educational obstacles, exposure to bias, health issues, disability, immigration status, surviving abuse, experiencing discrimination or complex family circumstances like incarderated parents, homelessness, or being raised in foster care. This is not an exhaustive list; it's an opportunity to share any additional aspects of your background that may provide the admissions committee with a better sense of your strengths as a student and classmate. The adversity statement should not exceed three pages, double-spaced, using 12-pt font with 1-inch margins.

### Scholarship Assistance

No separate application is necessary for scholarship consideration. Scholarship assistance is made possible by the Indiana University Maurer School of Law and by the generous support of alumni and friends of the school. Direct Admit Applicants who are accepted will be considered for a scholarship up to 50% of tuition. Most scholarships will be renewed each academic year as long as you maintain satisfactory academic progress (good standing of a 2.30). A small group of scholarships have additional renewal criteria. *Note: If an LSAT is taken, the score could impact the Direct Admit scholarship amount.* 

### Loan Programs

The form used to apply for federal student financial aid is called the Free Application for Federal Student Aid or FAFSA. For the academic year, you will be using your prior year's income and asset information to complete the FAFSA. It's best to complete your federal tax return early to have the data available, but you can file the FAFSA before you actually file your taxes. For information and to complete the FAFSA, visit <u>https://studentaid.gov/</u> or call 1.800.4.FED.AID (1.800.433.3243). Be sure to make a copy of the FAFSA for your own records. # Character and Fitness

Because of the high ethical standards of the legal profession, law school applicants need to be aware that "failure to disclose" an act or event that pertains to your character and honesty on this application may result in revocation of admission or disciplinary action by the Maurer School of Law or denial of permission to practice law by the state in which an applicant seeks admission.
