



### New program provides 10 full-ride MBAs to law students

The Law School and the SKK Graduate School of Business of Sungkyunkwawn University, Seoul, have announced that the graduate school will award full-tuition MBA scholarships to law students beginning this fall. As part of the new Indiana Law/SKK Graduate School of Business International Fellows program, scholarships will be awarded to as many as 10 academically qualified students admitted to SKK Graduate School of Business' MBA program as part of the Law School's unique international JD/MBA program. Each scholarship award is estimated at \$30,000 per student. The international fellows will typically complete two years of study on the Bloomington campus, then transfer to Korea for one year to earn credit toward their MBA before returning to IU to complete the joint degree program. No GMAT score is required for admission, and the students earn their JD and their MBA in only four years.

"This is an unprecedented collaboration between one of the world's leading business schools and a renowned law school across two continents, to provide a unique global experience for its participants," said Jae Ha Lee, dean and professor of finance at SKK Global School of Business. "A Maurer School of Law JD candidate will acquire cutting-edge business knowledge and earn a first-class MBA in a multicultural learning environment."

#### Conservation Law Clinic wins Lake Michigan case

The next time you walk the shoreline of Lake Michigan, be sure to remember the Conservation Law Center. In February, the Indiana Supreme Court preserved a Court of Appeals ruling on the applicability of the public trust doctrine to the Lake Michigan shore, and went a step further than anticipated -- an affirmation that the state of Indiana actually owns the lake shore up to the ordinary high water mark. With attorney **Jeff Hyman**, '03, leading the litigation, the CLC represented environmental groups Alliance for the Great Lakes and Save the

Dunes in a bid to protect the public's right to use the Lake Michigan shore as public land. "This is an important affirmation of the extent of Indiana citizens," said CLC Director **W. William Weeks III**, '79. "Taking the case was a risk for the center, and along the way, we have sometimes asked whether it was worth it. This result is just about all we could have asked for. With all due modesty, the Court relied heavily on the scholarship of Jeff Hyman's brief; I have no doubt that the protection of this great natural resource would have been less likely without CLC's participation in the dispute." ## Tax, IP, international law programs all make US News top-25

The release of the 2019 *U.S. News & World Report* Best Graduate School rankings this week saw several Indiana Law programs make positive gains. The school's tax law program (led by Prof. **Leandra Lederman**) climbed up to 17th in the nation, moving up six spots from last year. Intellectual property (headed by Prof. **Mark Janis**) also rose six places, from 27th up to 21st. International law was also recognized as a top-25 strength of the school, coming in at 23rd. Overall the Maurer School of Law was tied at 32nd nationally. The Law School offers joint JD/MPA and JD/MSES degrees with IU's School of Public and Environmental Affairs, which was ranked first nationally for the second year in a row.
