Abstract:

Wilbur F. Pell, Jr., a 1937 graduate of Indiana University and a 1940 graduate of Harvard University Law School, joined his father's law firm in Shelbyville, Indiana. During World War II, he worked as a special agent for the Federal Bureau of Investigation, later returning to central Indiana to become a senior partner in the family firm. From 1953 to 1955, Pell was deputy attorney general for Indiana. In 1970, President Richard Nixon appointed Pell to the Seventh Circuit Court of Appeals where he served until his retirement in 1984. Wilbur F. Pell, Jr. died September 25, 2000. Throughout his career Pell was active in the American Bar Association, the Indiana State Bar Association, and innumerable other organizations. This collection contains the materials related to his career and his activities as a judge. These materials also include photographs, memorabilia, and news clippings describing Pell's personal life.

Biographical Note:

A native of Shelbyville, Indiana, Wilbur Pell dedicated much of his life to the practice of law. Pell was born in December, 1915, to Wilbur F. and Nelle A. Dickerson Pell. As a teenager he attended Shelbyville High School, later moving to Bloomington, Indiana, where he attended Indiana University. While at Indiana University, Pell became head editor of the IU's humor magazine *Bored Walk* and of the university yearbook *Arbutus*. After receiving his A.B. in history in 1937, Pell attended Harvard Law School, graduating in 1940 cum laude. The same year, Pell married Mary (Chasey) Lane Chase

on September 14. Pell returned to Shelbyville to join his father's law firm. There was a brief interruption in his work from 1942 to 1945 when Pell worked as a Special Agent to the Federal Bureau of Investigation.

Following his return to law, Pell became an active member in the local and state communities. He served on the board of directors of Shelbyville Community Chest (1947-1949), director of the Westminster Foundation at Indiana University (1947-1949), director and chairman of the Shelby National Bank (1947-1970), Director of Shelby County TB Association (1948-1965) and president of the same association from 1965 to 1966. Pell also participated in the Shelby County Fair Association (1951-1953), and acted as district governor (1952-1953) and as president (1959-1961) of the Chicago Rotary Club. He also acted as the district chairman of Boy Scouts of America (1956-1957), the Shelby County President (1957-1958), President of the Seventh Federal Circuit, Indianapolis (1962-1963), and as Chairman House of Delegates (1968-1969). In addition, Pell was also an active member in Blue Key, Alpha Phi Omega, Theta Alpha Phi, Tau Kappa Alpha, the American Bar Association, the Fellow American College of Probate Counsel, the American Bar Foundation, American Judicature Society and National Conference of Bar Presidents, Republican.

The recipient of many awards including honorary law degrees from Yonsei University, Seoul, Korea, John Marshall Law School, and Indiana University, Pell was honored with the *Sagamore of the Wabash* both by Governors Otis Bowen and Robert Orr. In 1973, he received the American Bar Association's Judge Edward R. Finch Law Day U.S.A. Speech Award for the best Law Day speech in the United States.

From 1953-1955, Wilbur Pell served as Deputy Attorney General for Indiana. In late 1969, Pell was nominated by President Richard M. Nixon to serve on the Court of Appeals Seventh Circuit. Pell was appointed for life by Nixon on May 11, 1970. Among his more noteworthy cases is the Chicago Seven Trial (1969-1970) for which he filed the only dissenting opinion. Over the years, Pell shared regular correspondence with various members of the judiciary including Supreme Court Justices Rehnquist, Burger, and Stevens. Additional correspondents include Alfred P. Murrah, Richard M. Nixon, Nelson Rockefeller, Dan Quayle, and columnist Ann Landers.

Pell passed away at the age of 84 in September 2000.

Scope and Content Note:

The Wilbur F. Pell, Jr. Collection includes items from Pell's career beginning with his school days at Indiana University in the 1930's until the mid-1990's. Material relating to his activities at Indiana University, with various legal associations such as the American Bar Association, and his work on the Seventh Circuit Court of Appeals are well-represented. This collection is organized into two main series: professional and personal.

Comprising the bulk of the collection, the professional series is further organized into several sub-series. The first sub-series, Correspondence, spans from 1929 to 1999. The

correspondence is comprised of a variety of letters to and from Pell, organized chronologically, which relate to a variety of matters. Correspondents include J. Edgar Hoover, L.L. Bean, Elvis Stahr, John F. Kennedy, Nelson Rockefeller, Alfred P. Murrah, John Paul Stevens, Richard Nixon, Dan Quayle, William Rehnquist, and Warren Burger among many others.

The second sub-series, Court Materials, is organized topically. Materials in this subseries relate to Pell's work on the administration of Unites States courts, various appellate seminars, the Chicago Seven Trial, the Criminal Justice Act, moot court proceedings at the University of Illinois at Urbana-Champaign, Indiana University, and Loyola College, various opinions, judicial salaries, and the Seventh Circuit Court of Appeals. Items in this latter subject include correspondence, conferences, reports, writings, and case files. This sub-series also includes items on Judges Warren Burger, Julius Hoffman, and John Hastings.

Materials created during Pell's work as an FBI Special Agent comprise the third subseries. Items included here are several notebooks, serial publications, manuals, and various memos, bulletins, and certificates.

The large quantity of materials in the Organizations sub-series led to the further subdivision into sub-groups. These sub-groups are the Indiana State Bar Association (ISBA), legal organizations, and non-legal organizations. Occupying five boxes, ISBA materials span from 1939 to 1996. The content of this sub-group includes materials relating to various committees, the board of managers (1962-1963, 1968-1969), conventions, the House of Delegates (1966-1977), minutes, and the *Res Gestae*. Among the organizations represented in the legal organizations sub-group are the American Bar Association, American College of Probate Counsel, Federal Judges Association, Harvard Law School, Illinois State Bar, Legal Club of Chicago, the National Center for Public Interest, Shelby County Bar Association, and the World Peace through Law Center. Items in the non-legal organization are from Pell's work with Boy Scouts of America (1946-1961), Experiments in International Living, Indiana University Alumni Association, the National College of Education, Shelbyville Chamber of Commerce, the Union League of Chicago, and the Wi-Hub Club.

The fifth sub-series, Speeches, spans the years 1959 to 1999. This sub-series includes draft and final versions of speeches that Pell gave throughout his career, including the award-winning Law Day Speech. Also in this collection are programs for events in which Pell participated.

Pell's many writings comprise the final sub-series. Included are drafts and print copies of articles Pell wrote throughout his career. In some instances Pell's research materials are also present. A sampling of article titles includes "Read Before Signing," "Abstention," "Bride Said 'Ja'," "Ethics of American Professional Life," "Legal Ethics," "Nocturnal Journey," and "Saga of the Santa Fe." Also included are materials and sketches for a biography on Chasey Pell as well as for Pell's father Wilbur F. Pell, Sr.

The second series is comprised of materials describing Pell's personal life. This series is divided into five sub-series: College Publications, Law School Notes, Memorabilia, News Clippings, and Photographs. The College Publications sub-series includes a complete run of the *Bored Walk* from 1931 to 1937 as well as a 1917 edition of *Pearson's*. Items in the law school notes sub-series are unidentified notebooks, study materials on dockets, civil procedure, property, and the law of torts, as well as exams and essays from both Indiana University and Harvard University. The sub-series Memorabilia is comprised of such items as date books, a cast of Pell's bust, various certificates, graduation hoods from Indiana University, John Marshall Law School, and South Korea, a 1936 Indiana University *Arbutus*, documents from Shelbyville High School, and various travel journals. News clippings cover Pell's entire career. While the photographs span from 1937 to 1995, some memorable figures include Paul Harmon, William Bryan Lowe, Nelson Rockefeller, King Gustave V Adolph of Sweden, Madame Park and Princess Li of South Korea, Bob Hope, John F. Kennedy, Buzz Aldrin, and several judges.

Note on Added Materials: In 2009, an additional 24 boxes were added to the collection. These boxes contain case-related files from Pell's tenure as Associate Justice on the Seventh Circuit Court of Appeals. The materials include court documents, correspondence, case summaries, and in many cases, Justice Pell's personal notes pertaining to specific cases. In addition to his regular duties, Pell frequently served on 3judge panels in various circuit districts throughout the country and was called upon in a number of Independent Counsel cases as well. Of particular note, are the extensive files pertaining to several high-profile cases in which Justice Pell played a role. Among them:

- David Dellinger, one of the original "Chicago 7" defendants charged with conspiracy and intent to incite a riot following the 1968 Democratic Convention. Pell served as judge during Dellinger's appellate trial.
- Oliver North, a retired Marine Corps officer best known for his role in the Iran-Contra affair, a political scandal of the late 1980's. North claimed partial responsibility for the sale of weapons via intermediaries to Iran, with the profits being channeled to the Contras in Nicaragua. North was convicted in 1989 of accepting an illegal gratuity, aiding and abetting in the obstruction of a congressional inquiry, and destruction of documents. Judge Pell served as an appellate judge who overturned the convictions.
- In Bandemer v. NAACP, Pell cast the lone dissenting vote in 1984 in a ruling that the legislative districts approved by the Republican-controlled Indiana General Assembly unconstitutionally denied Democrats their fair share of seats in the legislature.
- Alcee Hastings served as a federal judge before he was impeached for corruption and perjury and removed from office by Congress in 1989. Justice Pell served on the 5-judge panel that investigated the charges against Hastings prior to his impeachment.

Arrangement:

The collection is arranged into two series: professional and personal. Each of these series is further divided into several sub-series. The professional series is organized by correspondence, court materials, Federal Bureau of Investigations, Organizations (which is further divided into the three sub-groups Indiana State Bar Association, legal organizations, and non-legal organizations), speeches, and writings. Items relating to the personal series are filed into the following sub-series: college publications, law school notes, memorabilia, news clippings, and photographs. The third series contains material related to Mary Chasey Pell's academic and professional activities. This includes administrative records for the Mental Health Association, photographs, plaques, awards, certificates, and Smith College reunion material. Memorable materials are photographs of Chasey Pell with Rosalynn Carter. The inventory of the case-related materials added in 2009, appear at the end of the listing as Series IV.
